#### **EPA Releases External Civil Rights Guidance on Procedural Safeguards**

Today the EPA's Office of External Civil Rights Compliance, within the Office of Environmental Justice and External Civil Rights, released the Civil Rights Guidance on Procedural Safeguards: Requirements and Best Practices. This guidance document was created to assist recipients of EPA financial assistance (such as grantees) when developing and improving their legally required civil rights compliance efforts. It advances transparency by providing information to all stakeholders about obligations under civil rights laws and EPA's nondiscrimination regulations, and represents another step toward delivering on EPA's commitment to strengthening its external civil rights enforcement program.

The Civil Rights Guidance on Procedural Safeguards: Requirements and Best Practices includes a robust explanation of the civil rights laws administered by the Agency, and outlines best practices for building strong and effective civil rights programs for recipients of EPA financial assistance.

The Guidance discusses obligations to:

- designate a non-discrimination coordinator;
- publish a notice of nondiscrimination;
- adopt grievance procedures that assure prompt and fair resolution of complaints alleging federal civil rights violations;
- collect, maintain, and provide data to EPA upon request to show compliance with civil rights obligations;
- take reasonable steps to provide meaningful access to persons with limited English proficiency;
- provide equal opportunity to persons with disabilities; and
- ensure nondiscrimination in public participation processes.

For example, EPA's nondiscrimination regulations require, as a condition for receiving EPA financial assistance, that a recipient publish a notice stating that it does not discriminate on the basis of race, color, national origin, disability, sex, and age. Under the regulations, the notice must be posted in a prominent place in a recipient's offices or facilities. To assist recipients in meeting this requirement, the guidance outlines best practices to meet this condition, for example posting on a recipient's website homepage and also considering other methods of outreach such as newspapers.

## Read the Civil Rights Guidance on Procedural Safeguards: Requirements and Best Practices

While best practices are not themselves legal requirements, and do not modify or add to existing legal requirements, EPA believes that civil rights concerns may be addressed proactively by recipients if they have the tools necessary to engage in robust civil rights compliance efforts. This guidance does not replace or supersede any existing statutory obligations, but rather pulls together best practices to be responsive to asks from inside and outside of the Agency.

EPA's Office of External Civil Rights Compliance is working diligently to improve processes and provide helpful resources to all recipients, communities, and other stakeholders to ensure their success and partnership with EPA. Through this guidance document, and other resources available online, EPA is continuing to build a robust, responsive civil rights program.

#### **Molecular Farming is Growing**

Molecular farming, or the genetic engineering of plants to exploit them for use as factories to create novel proteins and compounds, is continuing to expand! According to Research and Markets, the global molecular farming segment is expected to grow from \$454.1 million in 2023 to \$916.3 million in 2028, at a compound annual growth rate (CAGR) of 15.1%. Although a significant portion of this amount is related to the creation of recombinant proteins for medicine, we continue to encounter new developers who are using molecular farming to produce inputs for the food and body care sectors. Horizon scanning of potential environmental applications of terrestrial animals, fish, algae and microorganisms produced by genetic modification, including the use of new genomic techniques

With scientific progress and the development of new genomic techniques (NGTs), the spectrum of organisms modified for various purposes is rapidly expanding and includes a wide range of taxonomic groups. An improved understanding of which newly developed products may be introduced into the market and released into the environment in the near and more distant future is of particular interest for policymakers, regulatory authorities, and risk assessors.

Similarly, as for transgenic organisms, potential environmental risks may be associated with the introduction of genome-edited organisms. The spread of NGT organisms and/or spread of the modified genes into wild populations and communities may have unpredictable and possibly adverse consequences for the exposed ecosystems. #### GMO Seeds: A growing concern for soil's health, human well-being

The use of genetically modified organism (GMO) seeds has become a contentious issue, with mounting evidence suggesting they may pose significant risks to soil health and human well-being.

As GMOs become increasingly prevalent in agriculture, experts are raising alarms about their long-term impacts on the environment and public health.

One of the primary concerns with GMO seeds is their impact on soil health. Research indicates that the widespread use of GMO crops, particularly those engineered for herbicide resistance, can lead to a reduction in soil biodiversity.

The heavy application of glyphosate, a common herbicide used with GMO crops, is linked to the decline of beneficial microorganisms in the soil. These microorganisms are crucial for maintaining soil fertility, aiding in nutrient cycling, and supporting plant health. (Read more **here**
