Under Threat: Nevada's National Monuments Face Critical Federal Review

NEVADA — The Department of the Interior, under recent federal directives, has launched a comprehensive review of the protective status of several national monuments across the United States, including key sites in Nevada such as Avi Kwa Ame. This review could lead to a reassessment of land designations that have historically restricted mining and energy development activities. The aim is to evaluate whether changes are necessary to the current management and protection levels of these lands to better align with broader economic and policy objectives set by the Administration.

Mathilda Guerrero Miller, Government Relations Director of Indigenous Voices of Nevada, issued the following statement:

"As we confront the federal review of Nevada's national monuments, we must emphasize the sacred nature of these lands—cherished ancestral lands of Indigenous communities. These landscapes, including Avi Kwa Ame, represent far more than natural beauty; they embody the deep spiritual and cultural heritage of Native peoples who have been their stewards since time immemorial. Our dedication to protecting these sacred landscapes is unwavering, and we are committed to continuing our efforts to honor and preserve these crucial parts of our nation's history and culture. We stand united in the fight to ensure that these lands remain respected and intact, guided by the voices and wisdom of the Indigenous communities to whom these lands are sacred. This is not merely a policy issue—it's a moral imperative to safeguard our shared heritage."

Mandi Elliott, Executive Director of the Nevada Outdoor Business Coalition, issued the following statement:

"It is an unequivocable fact that national monuments improve local economies. By threatening the newly appointed national monuments, the rural communities surrounding them are also being threatened. To revoke the national monument status of Avi Kwa Ame would be to spit in the face of the Nevadans, who widely supported the designation."

Jocelyn Torres, Nevada-based Chief Conservation Officer of the Conservation Lands Foundation, issued the following statement:

"Conducting a secret, slap dash review of national monuments shows that this administration knows how popular these public lands are and is scared of public scrutiny. Nevadans continue to show their love for public lands, including during the first Trump administration's attempt to privatize Nevada's sacred, historic and recreationally and culturally significant landscapes - Gold Butte and Basin and Range National Monuments.

"With roughly 85% of BLM lands already available for energy production and Nevada's monuments having little to no oil and gas potential, it's crystal clear that these recent orders targeting the 15% of public lands that are protected for the public's use have nothing to do with the nation's energy portfolio and instead are sneaky attacks to sell off our public lands."

Mitch Fry, President of Friends of Gold Butte, issued the following statement:

"We, the Board of Directors for Friends of Gold Butte, urge President Trump, Secretary Burgum, and all elected officials to preserve our national monument, Gold Butte, and all national monuments in our country.

"Our national monuments have for generations allowed us to safeguard our water, wildlife, and ways of life. The landscapes, waterways, and stories they preserve are fundamentally a part of the American identity. That's why, since 1906, millions of Americans and Presidents of both parties have valued the Antiquities Act as a tool to preserve these lands and all they represent to all Americans."

Kristee Watson, Executive Director of Nevada Conservation League, issued the following statement:

"Our western way of life in Nevada was built on resilience, gratitude, and respect. Values that start at our kitchen tables and extend beyond to our public lands and national monuments like Avi Kwa Ame, Gold Butte, and Basin and Range. Over the last year, 81% of Nevadans visited a national park, forest, monument, or wildlife refuge because we love our land. Outdoor recreation drives economic growth through jobs and tourism and contributes \$8.1 billion to our state's GDP. For over 119 years, regardless of political party, leaders have listened to a chorus of voices, from hunters and anglers, to tribal leaders and conservationists, to grant protection of the Wild West as we know it. The Department of the Interior and <u>billionaire Secretary Burgum</u>'s overreach to reassess monument designations is an attack on our state's thriving outdoor economy, our tribal communities, and our freedom."

Deb Haaland, a former Democratic House member and Interior secretary under Joe Biden, launched a run for New Mexico governor on Tuesday.

Haaland would be the nation's first Native American woman to serve as a governor if she is elected to succeed term-limited Democratic Gov. Michelle Lujan Grisham, herself a former House lawmaker.

In <u>a video message</u> kicking off her campaign, Haaland emphasized kitchen table issues, pledging to lower costs and make rent and housing affordable. "New Mexico is rich in tradition and spirit," she said. "Rich in natural resources. So why can't our families pay our bills?"

Haaland also addressed crime and addiction in her video and said she intends to travel the state to hear directly from New Mexicans.

Haaland, who was the losing Democratic lieutenant governor nominee in 2014, is the biggest name to enter the race so far. Democratic Sen. Martin Heinrich <u>opted against a bid</u> last month, saying in a statement that "New Mexico needs a strong voice in Washington now more than ever." No major Republican has announced a campaign as yet, although former Rep. Yvette Herrell and 2024 Senate candidate Nella Domenici have been mentioned as potential contenders.

Haaland's video message emphasized her personal struggles. She raised a child on her own and relied on food stamps for groceries. "In my life, I've learned that nothing comes easy," she said. "I worked at the local bakery, sold my homemade salsa, cleaned at my child's preschool to reduce the bill."

Haaland, a former chair of the New Mexico Democratic Party, was first elected to the House in 2018, when she and Kansas Rep. Sharice Davids became the <u>first Native American women</u> elected to Congress. She resigned in 2021 to join the Biden administration as Interior secretary, again making history as the first Native American to serve as a Cabinet secretary.

She is the first former Biden Cabinet secretary to formally announce a 2026 campaign, but at least two others are considering bids. Former Transportation Secretary Pete Buttigieg is weighing a run for <u>Michigan's open Senate seat</u>. And former Health and Human Services Secretary Xavier Becerra is said to be "strongly considering" the open governorship in California, a position for which former Vice President Kamala Harris <u>could also be a contender</u>.


Elon Musk plans to file a financial disclosure report to the White House, though it will remain confidential.

Judge John D. Bates of the D.C. Federal District Court has ordered the CDC to temporarily restore pages removed from its website to comply with Trump's executive order barring references to race, gender identity, or sexual orientation. The judge stated that these deletions put "everyday Americans, and most acutely, underprivileged Americans," at risk.



HISTORY BITS

- **1585 Feb 17** Columbus's second exedition to the New World sent 550 Native Americans to Spain as slaves (only 350 survived the trip).
- **1821 Feb 21** The first issue of the Cherokee Phoenix appeared, was aublished until 1834, was later revived and still in publication.
- **1861 Feb 18** Under pressure from federal officials, Cheyenne and Arapaho tribal leaders agreed to surrender much of Colorado that was guaranteed to them by an 1851 treaty only to face the fierce opposition of their tribes to the land cession.
- **1881Feb 20** Matt Canavaan, prominent citizen on the Constock, said "Among these Indians no one has ever found a harlot, a coward or a thief."
- **1890 Feb 19** An order was issued to Pyrami Lake tribal members prohibiting them from fishing on their reservation between January 15 and March 15.
- 1893 Feb 21 Nevada Legislature's Ways and Means Committee reported a resolution calling Congress to take Warlker River away from natives "on grounds that Pyramid Reservation is sufficient for the Indians, and Walker Reservation is mostly mining courntry such as the Indians have no use for."
- **1900 Feb 20** Chief Washakie died and was buried with full U.S. military honors and with a funeral train that stretched for miles.
- **1902 Feb 22** Indian agent Fred Spriggs denied that there was smallpox on the Pyramid Lake reservation and also denied that there was a quarantine in force.
- 1911 Feb 21 Comanche chief Quanah Parker walked on, buried at Fort Sill.
- **1944 Feb 22** Near Padiglione, Italy, **Lt. Jack Montgomery,** a Cherokee from Oklahoma, single handedly attacked three enemy positions that were firing on his unit, took prisoners and received the Medal of Honor.
- **1964 Feb 18** The Atomic Energy Commission invited utilities to submit proposals for a nuclear facility capable of generating 150,000 kilowatts.
- 1986 Feb 17 Timbisha Shoshone Constitution was certified.
- 1986 Feb 19 The US finally ratified the 1947 Genocide Convention, 39 years after the December 9, 1947, adoption by the General Assembly of the UN and 37 years after the June 16, 1949 submission by President Truman, one of eight presidents who asked for its ratification.

A program to close insurance gaps for Native Americans has gone largely unused. Last year, a tribal health insurance sponsorship program in Nevada was introduced. The program offers coverage for Native Americans through the Affordable Care Act marketplace and allows tribes to pay the premiums for their members, increasing access to care outside the tribal system. It has helped many in Nevada, with more tribes expected to join. However, there are concerns about the expiration of enhanced tax credits that could increase premiums. (Via KFF Health News)

Eel River pact redresses past wrongs, provides model for compromise among diverse interests, officials say "There was emotion


in the room Thursday as public officials from around the North Coast gathered in Sacramento for a ceremonial signing. They were putting their names to a historic agreement on the future of the Eel River that secures crucial water supplies for the Russian River <u>watershed</u> while redressing past oversights and injustices. Negotiated over more than six years to chart a way forward once Pacific Gas & Electric decommissions its Potter Valley powerhouse and tears out dams that have degraded the Eel River and imperiled fish species, the multiparty pact gives equal attention to river restoration needs and to modernizing water diversions for Russian River users in Sonoma and Mendocino counties. In the process, it confers Eel River water rights to the Round Valley Indian Tribes in northeast Mendocino County, requiring beneficiaries on the Russian River to pay them \$1 million a year for the privilege of transferring water from the Eel into the Russian River. ... ^(%) "A record-setting dry start to the water year in southern California and Nevada led to Extreme Drought (D3) in the region—and now Exceptional Drought (D4) in Nevada—according to the U.S. Drought Monitor. The first four months of Water Year 2025 were among the top three driest October–January periods on record for California's South Coast Drainage (2nd driest) and Southeast Desert Basin (3rd driest) climate divisions and Nevada's South Central (3rd driest) and Extreme Southern (driest) climate divisions. A recent storm and an ongoing atmospheric river are bringing much needed precipitation to central and southern California and Nevada. This will mitigate some of the most acute drought impacts, but drought conditions will remain. Drought preparedness is key for California and Nevada. But the Sierra Avalanche Center announced this week that due to ongoing staff cuts by the federal government, it may have no choice but to cut back on the number of forecasts it issues.
